## **Prologue**

The perception that goes around along the banks of Ichhamati and encircling Taki, is that the Taki Government College is a phenomenon manifesting itself in various characteristic attires such as heritage, excellence, dynamism, learning, leadership, inspiration, self-determination and so on so forth. The phenomenon Taki Government College started its journey into the educational arena of West Bengal on 15th September 1950. Since then, the College has traversed a long way accumulating optimistic ingredients in its stature to arrive at its present momentous state. Located a few steps away from the banks of the river Ichhamati, the College is fulfilling the educational needs of a large section of students belonging to the vast adjoining areas withever increasing sense of commitment.

Taki is well connected both by railways and by roadways. Nearest railway station from the College is Taki Road Station in the Sealdah-Hasnabad section.

Academics of the College are conveniently spread in three parts of the main campus, the Main Building,

Annex Building, and the Geography-cum-playground enclave. Main building hosts the office of the Principal and most of the academic departments. Students" Council Room and the college Canteen are located within the main building enclosure. Over the years, the College has been gaining momentum in upholding its pledge towards inclusive education and thus maintaining sustenance of tradition, culture and heritage inherent to the State of its positioning. The full time Teachers of the college are appointed by the Government of West Bengal under the cadres of West Bengal Educational Service (W.B.E.S.) and West Bengal Senior Education Service (W.B.S.E.S), as per the norms promulgated by the University Grants Commission. The Teachers are liable to be transferred to different Government Colleges as per W.B.E.S & W.B.S.E.S stipulations. The Government of West Bengal also appoints support staff required to be posted in various sections of the college. A considerable number of part-time teachers are also engaged to shoulder academic and otherwise responsibilities. Retired teachers are sometimes assigned to undertake teaching as guest lecturer. The Education Directorate and the Higher Education Department of the Government of West Bengal are the immediate controlling authority of the College administration and frame the dynamic policies as well as functional modalities of the College that are carried through and implemented by the Principal/ Officer-in-Charge of the College. A Governing Body is at the centre stage of the College Administration. The present Governing Body is headed by the Sub Divisional Officer (SDO) who acts as its president with the Principal of the College being the Member Secretary. The College boasts of having a well-set Internal Quality Assurance Cell (IQAC) which is an essential stipulation of UGC, India.

A computer training centre, NSS, NCC and Netaji Subhas Open University are the additional opportunities which the students can explore. The college is facilitated by two students" hostels meant to cater to the needs of outstation candidates. However, both the hostels are non-conducive for residential purpose and proposal for renovation has been submitted to the higher authority. The College Library is well-stocked and is always nourished to be a platform towards and all-round development of the students. Seminars and allied Lecture sessions are held for the benefit of the students. Sporting activities take place round the year with the Annual Sports slated at suitable time every year. The students" union offers a platform to the students to voice their concern. Students can feel the sense of togetherness in collective activities in the common room or such other places in the campus and engage themselves in creative activities. Yearly magazine is published to enable students to develop their innate potentials.

The teaching and other support staffs of the college always strive to achieve excellence and further blooming of the college. Students are to abide by the rules and regulations of the college and it must be remembered that only through combined efforts of all of us, we can raise the college to better heights. ## **PROGRAMMES OFFERED**

For the academic session of 2024-25 under the Curriculum and Credit Framework for Undergraduate Programs (CCFUP) based on NEP 2020, the college is providing following course programs as per draft advisory for UG admission given by the West Bengal State University.

## Undergraduate course under NEP Scheme

#### A. Single Major programmes:

- (i) **4-year Bachelor's degree (Honours)** with Major in the field of Arts/Science (8 semesters).
- (ii) **4-year Bachelor's degree** (**Honours with Research**) with Major in the field of Arts/Science/Commerce/Management (8 semesters). Students need to complete a research project of 15 credits in areas of their Major discipline in the 4<sup>th</sup> year of studies.
- **B. Multidisciplinary programmes:**
- (iii) **3-year Bachelor's degree with Multidisciplinary programme** of studies in Life sciences/ Physical Sciences/ Mathematical & Computer sciences/Social sciences/ Humanities (6 semesters).

#### **ELIGIBILITY FOR ADMISSION IN THE UG PROGRAMMES:**

A candidate who has passed the Higher Secondary (10+2) or its equivalent level examination is eligible to seek admission to the First Semester of the Eight Semester B.A./B.Sc (Hons and Hons. with Research) or in the First Semester of Six semester Multidisciplinary B.A./B.Sc. Course of studies provided he/she has also passed in English having full marks not being less than 100. In any case, where there is an ambiguity regarding the admissibility of a particular examination at the Higher Secondary (10+2) level of study, the matter shall be referred to the Equivalence Committee of the University who shall determine the eligibility

of the saidexamination. However, no candidate, in general shall be allowed for admission in the course

after a lapse of more than 3 years from the year of passing the previous qualifying examination. The year of admission shall not be taken into account while calculating 3 years from the year of passing the previous qualifying examination. However, in exceptional cases a candidate may be allowed for admission after 3 years of the previous qualifying examination, but, within 3 years after discontinuation of a recognized regular Course of Study. Those desirous to do so will seekpermission from the University Authority. For the purpose of determining eligibility for admission to the 4-year Honours Course, aggregate marks shall be calculated by adding the marks of top four subjects in order of marks secured by acandidate. However, marks in compulsory Environmental Education/Studies shall not be taken into account for calculation of aggregate marks. If the subject "Environmental Science" is studied as an elective subject of 100 marks, it may be taken into account for the purpose of determining the aggregate marks. For the purpose of determining eligibility for admission to the 3-year Multidisciplinary UG programme of study, aggregate marks shall be calculated by adding the marks of top four subjects in order of marks secured by a candidate. However, marks in compulsory Environmental Education/Studies shall not be taken into account for calculation of aggregate marks. If the subject "Environmental Science" is studied as an elective subject of 100 marks, it may be taken into account for the purpose of determining the aggregate marks. A candidate taking up Honours/ Major in a subject must have obtained a minimum of 50% marks in the aggregate and 45% marks in the subject or related subject at the previous qualifying examination. OR 55% marks in the subject or related subject in the previous qualifying examination OR 50% marks in the aggregate when the candidate has not studied the subject in his/ her previous qualifying examination provided all other clauses are satisfied. Candidates belonging to the Scheduled Caste or Scheduled tribe category must have obtained 40% marks in the aggregate and 40% marks in the subject/related subjects at the previous qualifying examination (10+2 level) for being eligible for admission in the Honours programme of study. Candidates from who have passed the Higher Secondary (10+2) examination or its equivalent from the All-India Boards/Councils or State Boards/Councils including Open Schools and vocational studies are also eligible for studying at the UG level.

#### Post Graduate Department of Bengali:

The College offers two years Post Graduate course in Bengali. The course was introduced in the year 2005 with the administrative approval of Higher Education Directorate, Government of West Bengal. Primarily this P.G. course was affiliated to the University of Calcutta and after the formation of West Bengal State University in 2008, the course had been affiliated to this University.

#### Post Graduate Department of English:

Department of English has the facility of teaching Post Graduate course alongside the undergraduate under the

affiliation of the same West Bengal State University. This PG Course was introduced in the year 2014 with the administrative approval from the Higher Education Directorate, Government of West Bengal and is completely autonomous that runs under the administrative control of the same University.

### **ADMISSION PROCEDURES:**

#### **General Guidelines of Centralised Admission Portal**

- 1. Any candidate who has passed 10+2 or equivalent examination may register the online centralised portal, subject to certain restrictions in terms of the year of passing as set by the concerned Universities/Colleges/Higher Education Institutions.
- 2. A candidate can search programmes, colleges, and universities even before registering in the portal and access all relevant details, such as course / programme - wise eligibility criteria, number of seats (category-wise), formula for merit-index calculation, combination subjects offered, college profile, etc.
- 3. To register, candidates must provide a mobile number as their primary contact. This mobile number will be used for identification of the candidate and communication throughout the Centralised Online Admission Process. Additionally, the candidate must also provide a valid e- mail address to receive different communications from the portal during the Centralised Online Admission process (UG). Candidates are advised not to change their mobile number during the entire process of online admission, as it may result in not receiving important communications from the portal from time to time.
- 4. As a first step in the application phase, a candidate will create a profile, providing the necessary personal details.

Candidates must be cautious about all inputs provided, as this data will be used for eligibility criteria checking, merit indexing, and seat allotment by the system. There is no provision in the system for automatic validation or correction. If the candidature of any candidate is adversely affected due to the entry of wrong data by the candidate, the candidature of such candidates will be liable to be cancelled even after provisional admission. Information to be provided by the candidates is given below:

- Additional Information
- o Results
- Documents
- 6. Once the profile is successfully created and submitted, a candidate can check her or his eligibility with respect to any course / programme in any college in any district under any University of West Bengal under the purview of the portal under reference. Eligibility will depend on the course / programme and HEI, and the details of the eligibility criteria will be made available in the portal.
- 7. A candidate will be allowed to apply for a maximum of 25 courses / programmes (for which the candidate is eligible) across one or multiple institutions.
- 8. A candidate applying for multiple courses / programmes will be required to rank the courses / programmes in order of her or his preference. As the candidate is allowed to apply to multiple courses / programmes, marking of the preferences in the applications is to be done carefully, as the seat allotment will be done on the basis of preferences exercised by the candidate. A candidate can change the preference list by adding or deleting courses / programmes or by re- ordering the list any number of times until the closure of the application window.
- 9. If a candidate does not indicate any preference, they will not be able to submit the application.
- 10. A candidate can change his or her profile information at any point in time before the application window closes. In the event of any change in marks, the candidate must prepare the preference list afresh.
- 11. Candidates must be very careful while applying. Candidates are advised to select the maximum possible number of courses / programmes in the same or different institutions (up to 25) and carefully rank their preferences. Candidates will be allotted their highest

- available preference (at that material point of time) based on merit rank and the availability of seats.
- 12. Candidates applying for 4-Yr Hons. / Hons. with research / 3-Yr Multidisciplinary Courses / Programmes must choose Major and Minor subject(s) during the application process (subject to confirmation of minor subject combination at the time of physical verification by the college/ HEI). For B.Com. 4-Yr Hons. / Hons. with research / 3-Yr Multidisciplinary Courses / Programmes there shall not be any scope for selection of combination of subjects.
- 13. On closure of the application window (by 11:59 p.m. of the last date of submission of application form), profile information and applications with preference rank will be autosubmitted, and no further changes can be made. The candidate may anytime login to the portal and download the application form throughout the entire period of the centralised online admission process.
- 14. A Unique Application Number will be generated for each applicant once the application is submitted. This Unique Application Number will be used to identify the candidate throughout theentire admission process.
- 15. Candidates will find a FAQ segment in the portal, which may help them resolve their queries. If this is not resolved, they may refer to the "contact us" section of the portal.
- 16. Admissions in Sports Quota Seats (if any) will not be considered in the UG Centralised Online Admission portal.

#### Phase: I ( Admission Round and Upgrade Round)

- 17. After the closure of the application window, the Merit Index will be generated by the system for each course / programme in each institute (both the general merit list and the category-wise merit list), and all eligible candidates will be ranked as per their Merit Index (in descending order) in the respective lists.
- 18. The merit index will be calculated based on the ranking rules provided by the concerned Higher Education Institution (HEI) for each individual course / program.
- 19. A General Merit Rank (GMR) list will be generated based on the merit of candidates in all categories for each and every institution and Course / Programme.
- 20. A Category Merit Rank (CMR) list will also be generated for reserved category candidates for each and every institution and Course / Programme.
- 21. No separate rank will be generated for PwD or differently abled candidates. However, there will be horizontal reservations for PwD candidates in all categories where such applicants are available, as per the government rules now in force.
- 22. The seat allotment will be published on a scheduled date, duly notified from time to time.
- 23. Allotments will be given based on the information provided by the candidates. On scrutiny, if it is found at any stage that the applicant is not eligible for the allotment because of some discrepancy in the data provided by the candidate or due to the unavailability of supporting document(s), the corresponding allotment or provisional admission shall be treated as cancelled.
- 24. Candidate will login to check the allotment. The allotment status will show the institute and course / programme in which the candidate has been allotted a seat, if any. The candidate will be able to see the corresponding GMR and CMR for all the applications in the candidate spreference list.
- 25. Seat allotment will be done HEI / Course / Programme-wise according to merit and preference.
- o UR seats will be allotted to candidates irrespective of their social category.
- PwD candidates will be placed against their respective seats.
- o Candidates other than PwD will be placed against UR seats not reserved for PwD.
- o The same procedure will be followed for the reserved category seats.
- o If a UR-PwD candidate is allotted a UR-PwD seat, the same candidate will not be considered for any other UR seat. The same rule applies for the other reserved categories as well; for example, SC-PwD, ST-PwD, and OBC A & B PwD candidates allotted seats in these categories will not be allotted any other seat in the SC, ST, or OBC A and B

categories.

- Seats for reserved category will be allotted based on their social category following existing rules of reservation of seats for admission to Higher Education Institutions, Government of West Bengal (07-Edn(U)/1U-89/13 dated 02nd January, 2014). Seats for EWS will be allotted in terms of government order bearing no 339-Edn(CS)/OM-74L/2023 dated 26th May,2023 read with 628- Edn(CS)/OM-74L/2023 dated 18th September, 2023 subject to the submission of valid EWS certificate issued by competent authority in terms of government order number 334-BCW/MR- 52-2028 dated 27-02-2024.
- o If a reserved category candidate belonging to SC, ST, OBC-A or OBC-B is allotted a UR seat by merit, the same candidate may also be allotted the respective reserved category seat, if eligible. Inthat case, the same person may be allotted 02 (two) seats for the same course / programme / HEI combination. In such cases, the candidate will have to opt for one (either UR or Reserved Category) seat at the time of taking provisional admission.
- While allotting a seat to a candidate, the following rules will be applicable:
- A candidate will be allotted the highest available ranked seat as indicated in the preference list submitted by the candidate. This allotment will be made based on the candidate"s rank in the merit index list and seat availability for the particular course / programme.
- Once allotted a seat, all choices of that candidate for the same rank and below in the preference list will not be considered for seat allotment in future. This is to ensure that candidates who are allotted seats will be considered for upgrading only in the next round by selecting upgrade option at the time of admission in the allotted seat. If a candidate is allotted a seat against the first preference, the candidate will not be considered in later upgrade rounds (if any).
- If there is a tie between candidates with the same Merit Index for seat of a particular course / programme (category-wise), the tie-breaking rule as prescribed by the concerned HEI (College / University) will be used to break the tie. A candidate may not be allotted any seat if the candidate's rank in the merit list is lower than the last candidate allotted in the respective course / programme for the HEI applied in the candidate's respective categories.
- o After seat allotment to all possible candidates, the portal will be opened for a defined timeline for the candidates to take <u>provisional admission</u> to the seats allotted to them, if

any

- The candidates have to proceed with taking admission into the allotted seats. The candidates who will not take admission in the allotted seats in the respective round will not be considered for any further upgrading. The candidature of such a candidate will be irrevocably cancelled.
- A candidate who has taken admission to the allotted seat in the respective round may opt for upgradation, if not allotted in the top-most preference given by the candidate.
- o For any future allotment in the upgrade round, the candidates who were allotted a seat and all choices of the same rank and below in the preference list will not be considered.
- For provisional admission in the allotted seat, the candidate must confirm and accept the admission fees and pay the same through the online payment mode as available in the system.
- Admission fees will be according to the fee structure as prescribed by the respective HEIs. The fees may vary due to the selection of a combination of subjects.
- On successful payment, the candidate will be considered to have been provisionally admitted, and the candidate will be provided with a downloadable provisional admission slip.

#### Allotment of Seats and Admission in Upgrade Round of Phase I

- 26. After the closure of the first round of admission, candidates who have already been admitted to the allotted seat in the said round will be considered for upgrading, if opted by the candidate.
- 27. For the candidates who were allotted a seat in the first round, choices that are ranked higher than the allotted seat will only be considered when allotting seats in the upgrade round. This rule will apply to already-provisionally admitted candidates.
- 28. Candidates who were allotted their first preference seat in the first round, irrespective of

whether they took provisional admission or not, will NOT be considered in upgrade round.

- 29. Only those seats where no admission has been taken in the first round will be considered as "Available Seats" for the subsequent upgrade round.
- 30. Seats reserved for the scheduled caste candidates and remaining unfilled seats will be filled by Schedules tribe candidates, and vice versa. Likewise, seats reserved for OBC-A candidates remaining unfilled may be filled by OBC-B candidates, and vice versa.
- 31. The upgraded allotment will be declared on the portal on a pre-scheduled date which will be available on the Notice Board of the Portal.
- 32. After seat allotment, the portal will be opened for a pre-defined period for the candidates to take provisional admission to upgraded seats allocated to them, if any.
- 33. If an already provisionally admitted candidate is allotted a seat in the upgrade round, the candidate can opt for the upgraded seat. In that case, the candidate must confirm to irrevocably vacate the earlier seat. Alternatively, the candidate can opt not to take admission to the upgraded seat. In that case, the provisional admission taken in the first round will remain valid.
- 34. If a previously provisionally admitted candidate opts for the upgraded seat, the candidate will payonly the additional amount (admission fees) for provisional admission to the new seat.
- 35. If the admission fee for the newly allotted seat is less than the previous one, then the extra amount collected earlier will be refunded to the bank account provided by the candidate while filling the application form after the completion of the whole online admission process.
- 36. An admitted candidate in a particular programme may opt for cancellation of admission through this portal until the completion of the centralised admission process. Cancellation of admission may be done through the "Cancel Admission" button available on the applicant's dashboard (in the portal) after taking the provisional admission against the allotted seat. On cancellation of admission, the admission fees paid by the candidate will be refunded to the bank account provided by the candidate in the application form after the completion of the entire centralised admission process under the supervision of WBSCHE. Candidates, who opt forcancellation of admission after the completion of the centralised admission process, will have to apply to the concerned HEI (where the candidate has taken admission) for cancellation of admission.

#### Phase II: MOP-UP Admission

- 37. The remaining vacancies (if any) will be announced (college / course / programme / category-wise), after the closure of earlier admission process, on the "Notice Board" of the Centralised Admission Portal. Relevant notifications will be published in the websites of Higher Education Department / WBSCHE.
- 38. Fresh applications will be invited for the MOP-UP centralised admission round which will be notified in due course. Previously registered candidates in the first Phase may apply afresh through this portal, if they were not allotted any seat or not admitted against a seat allotted earlier. Such registered candidates shall have to prepare fresh preference list against the remaining vacancies notified.
- 39. Those who have already taken admission in the earlier centralised admission process will not be allowed to apply afresh. However, the candidates who cancelled their admission in the earlier centralised admission round may prepare fresh preference list against the remaining vacancies notified.
- 40. After the completion of the MOP-UP admission round, candidates who have already been admitted to the allotted seat in the MOP-UP round will be considered for upgrading, if opted for.
- 41. For the candidates who were allotted a seat in the MOP-UP admission round, choices that are ranked higher than the allotted seat will only be considered when allotting seats in the upgrade round of Phase II. This rule will apply to already-provisionally admitted candidates.
- 42. Candidates who were allotted their first preference seat in the MOP-UP admission round, irrespective of whether they took provisional admission or not, will NOT be considered in upgrade round of Phase II.
- 43. After seat allotment, the portal will be opened for a pre-defined period for the candidates to take provisional admission to upgraded seats allocated to them, if any.
- 44. If an already provisionally admitted candidate is allotted a seat in the upgrade round of Phase II, the candidate can opt for the upgraded seat. In that case, the candidate must confirm to irrevocably vacate the earlier seat. Alternatively, the candidate can opt not to take admission to the upgraded seat. In that case, the provisional admission taken in the previous round will remain valid
- 45. If a previously provisionally admitted candidate opts for the upgraded seat, the candidate will pay only the additional amount (admission fees) for provisional admission to the

- new seat in Phase II.
- 46. If the admission fee for the newly allotted seat is less than the previous one, then the extra amount collected earlier will be refunded to the bank account provided by the candidate while filling the application form after the completion of the whole online admission process.

#### **Document Verification**

- 47. Physical verification of documents of the candidate will be done at the HEI level after taking admission at the end of the concerned phase.
- 48. Candidates who will take provisional admission through the portal will report to the concerned HEI within the notified schedule for physical verification of documents. They must carry printed copies of their provisional admission slip and all academic and other relevant documents in original. If, during the physical verification of documents at the college/HEI, it is found that there is a discrepancy between the data provided in the portal and that found in the documents, which may have had an impact on eligibility and/or Merit Rank / Position, the provisional admission may be summarily cancelled. Admission will be finally confirmed only after successful verification of all relevant documents by the concerned HEI, followed by registration with the affiliated university.
- 49. Candidates must carry the following documents in original and one self-attested copy of each.
- Class 10th Standard mark sheet.
- o Class 10th Standard Examination Admit Card (Age Proof)
- Class 10+2 Standard mark sheet, Admit Card and Registration Certificate
- Social category certificate (if applicable)
- o Disability certificate (if applicable)
- Valid Photo ID Proof as submitted in the application form
- Aadhar Card (Preferably)
- System Generated Provisional Admission Slip
- 50. As a result of document verification If a candidate is found not eligible for any course / programme because of any discrepancy in data and/or document (which may have an adverse impact on the merit index of the candidate), the provisional admission of the candidate will be cancelled.

#### **General Rules to remain valid throughout the Centralised Online Admission Process:**

- 1. If a provisionally admitted candidate does not want to join or continue in the college/HEI, the candidate will have to apply to that institute for any refund within the prescribed period for cancellation of admission in terms of the relevant order in force. The department will not have any responsibility / liability in this regard and will not entertain any communication in this connection.
- 2. The provisional admission fees paid by the candidates who complete the admission process will be remitted to the respective college/HEI after the closure of the online admission process.

#### CAREER COUNSELLING AND PLACEMENT CELL






#### **SECURITY SERVICE**

#### **DISCIPLINE**

- ✓ Students admitted to this college must obey the rules and regulations of the college.

#### **SWOC Analysis**

#### Strength:

- 1. The College providesholisticeducation to diverse socio-cultural populace at a nominal cost andacts as springboard for theambitious students of rural hinterland.
- 2. 15 UG and 2 PGprogrammes under CBCS (from 2018)and NEP curriculum (from 2023) provide wide array of subject-combinations. WBSU approval for new Multidisciplinary Courses (MDC) under NEP Curriculum has benefited the students.
- 3. The cultural landscape and strong feeder institutions ensure steady demand for admission. Active monitoring and promotion of scholarshipschemes likeSVMCM, Kanyashree, OASIS, Aikyasreeensures that nearly all students enjoy scholarships.
- 4. Qualified faculties with different specializations are recruited as per norms of UGC and State government. Scope of inducting senior faculty through routine-transfer serves the students. IQAC encourages teachers to attendfaculty development programmes.
- 5. Digital learning and management through LMS portal where students participate in e-mode. The campus is Wi-Fi enabled. Students get computer access at the main computer laboratory and in the department of Mathematics and Geography.
- 6. E-governance incorporated in every sphere of administration, like admission, registration, scholarship, PG result, tender, purchase, finance etc. for transparency and effective delivery.
- 7. Well-stocked library, partially automated with KOHA, harbours nearly 96,000 books. Membership of N-List improves digital accessibility. The laboratories are well-equipped.
- 8. Academic seminars, career guidance, soft skill development programmes organized regularly.
- 9. MoU and departmental collaborations with peer institutions and research collaborations with premier institutions like IISER stimulate exchange of faculties, library and laboratory facilities, and enhances research capabilities.
- 10. Visible ambience of inclusivity reflects a positive churn in social dynamics. The number of girl students is more than the number of boys. Diversity of faith, social standing, gender and affluence are accommodated congenially.
- 11. Focus on cross-cutting issues like trafficking, eye-donation, thalassemia, electoral literacy, cyber-crime, cyclone relief, village adoption, promotion of sports, yoga etc.ensures holistic development.
- 12. Feedback fromstakeholders createsaccountability for employees and administration.
- 13. Health and mental well-being of staff and students is safeguarded by various schemes.
- 14. Notable alumnilikeformer Vice Chancellors of JNU and UBKV, former Chairman of BARC, Secretary-rank officers of Union and State Governments provide inspiration to students.

#### Weakness:

- 1. The college was set up in 1950 in a limited space and setting. However, the current enrollment ratio exceeds the infrastructural capability. Urgent requirements of infrastructural expansion and augmentation are hindered by the limited availability of suitable contiguous land parcel.
- 2. Plans for expansion of hostel facilities are similarly hindered due to limited availability of suitablecontiguous land parcel and/or funding issues in case of vertical development.
- 3. The size of the College auditorium and the College playground is not commensurate withthe total number of enrolled students, thereby restricting their sporting and cultural expressions.
- 4. While routine-transfer is a well-received policy, often the transfer of teachers creates a shortage of human resources and disrupts the momentum of teaching-learning processes.
- 5. Vacancies among support-staff in the Office and among laboratory bearers due to retirement etc. pose a threat to the smooth running of the institution.
- 6. Dependence on the Government on matters of policy, recruitment and finances implies limited sources of available solutions and funds to address specific academic concerns.
- 7. Distance from centers of academic excellence and good public libraries of national standard creates hinderance in the academic progression of students.
- 8. Lack of academic autonomy at undergraduate level restricts further academic expansion of the institution.
- 9. Loss of teaching days due to official requisition of college premises for general administration at the time of election etc. creates an unequal field when compared to the peer institutions.
- 10. Limited scope of career placement for many undergraduate students is a matter of concern.

#### **Opportunity:**

- 1. Consistent demand for admission to all undergraduate and post-graduate courses bears testimony to the goodwill of the college.
- 2. Success of students in all India Entrance Examinations like JAM, NET/SET, GATE, etc. and examples of students pursuing Ph.D at different institutions points to the quality of education.
- 3. Leveraging the digital infrastructure like LMS and Wi-Fi enabled campus shall provide better connectivity options and newer vistas of opportunity to the students.

- 4. Certificate courses launched by the college prepare the students for real-life scenarios and provide experiential learning outside the University curriculum.
- 5. Soft-skill development programmes like Career Counselling, Course in Communicative English will help students overcome mental barriers and communicate confidently in job interviews.
- 6. A grant of Rs. 2 Crore under Component-9 of RUSA 2.0 has put the institution in a position to leverage infrastructural growth. 97% of the first instalment of Rs. 1 Crore sanctioned under RUSA 2.0 has been utilized and next instalment for further infrastructural growth is awaited.
- 7. The recentlyawarded MPLAD grant Rs. 1 Crore has created an opportunity for construction of a new building equipped with more classroom, auditorium, laboratory etc. for further expansion of academic infrastructure of the college.
- 8. The competitive milieu of the locality in terms of sportinginfrastructure and cultural landscape provides opportunity to the students to excel in co-curricular activities, thereby ensuring their holistic development.

#### **Challenges:**

- 1. The consistent increase in intake capacity in the last few years, to accommodate benevolent policies of the Government, has impacted the teacher-student ratio. Sometimes this poses challenge to the capability of the teachers in terms of optimum delivery of services.
- 2. Retaining the intake capacity, in view of the infrastructural limitations, in the present scenario is a challenge.
- 3. Dependence on State Government for policy, long term perspective plan, recruitment, income, and expenditure is a structural pattern which the college cannot independently modify. However, the State Government always welcomes proposals for development.
- 4. Attrition among the students of Science stream in search of courses that assure placement is a challenge.
- 5. The disruptive and inescapable influence of COVID pandemic on the spheres of higher education is a challenge. Creation of any compensatory digital architecture shall require considerable funding and training which the College cannot sustain on its own.
- 6. Overcoming the digital divide prevalent among a section of students and Office Staffis also a matter of concern. Lack of resources is often compounded by poor connectivity in the region.
- 7. Introduction of NEP curriculum, with four parallel semesters running simultaneously, shall require adequate number of new classrooms, laboratories and more positions forteaching and non-teaching staff. The present

- structural deficiency to adequately address those frontsin a time-bound manner poses a risk to the institution given such high patternsof enrollment.
- 8. Retirement of State Aided College Teachers (SACT) or their resignation in view of better career prospects means loss of able, experienced faculty for the institution and no scope for replacement. Limited career growth opportunity for SACT is also an issue of concern.
